## Human Rights & Working Conditions

- Our Suppliers will not employ persons who have not reached the legal minimum age for admission to employment in the country where the work is carried out, in accordance with the Convention on the Rights of the Child (article 32).
- Our Suppliers do not use forced or compulsory labour and will comply with local legislation regarding the fight against modern slavery.
- Our Suppliers will not discriminate, exclude or provide any preference based on color, gender, religion, political opinion, sexual orientation, national descent or social origin. The Supplier shall comply with local legislation regarding the employment of persons with disabilities and the fight against all forms of discrimination.
- Our suppliers respect the rights of workers to freedom of association and collective bargaining. Workers are free to join or not to join any association of their choice.
- Our Suppliers protect the health, safety and well-being of its employees, service providers, subcontractors, and any person likely to be affected by its activities. Our suppliers comply with local legislation on working hours and comply with local legislation on minimum wages, benefits and overtime pay.
